- All riders must wear a helmet when handling a horse or riding a horse.
- Long sleeve shirts and boots with a heel are required throughout the day.
- Appropriate English and or Western attire is encouraged but not required.
- In Western events riders may ride two handed but in the event of a tie the horse in the appropriate bit for its age will get preference.
 - Horses five and under can be ridden two handed with a snaffle bit or bosal.
 - Horses six and older should be ridden one handed in a shank bit.
- Judge will ask horse related knowledge questions during showmanship.

I acknowledge that horseback riding is a sport which carries inherent risks of injury and damage to me, my horse, and property. I knowingly assume all risks, whether known or unknown of horseback riding.

I hereby release **Humboldt County 4-H and Redwood Acres Fairgrounds;** from all liability for any act of negligence, or want of ordinary care on the part of the person or person's, release and discharge the person's it's owners and agents and their representatives, heirs, executors and assigns from *any* and all claims of liability for injury or damage to myself, my animals or my property arising out of my participation in horseback riding. This agreement is binding *upon* my executors, heirs and assign.

I expressly waive any and all of my rights I may have under California Civil Code 1542, which states; "A general release does not extend to claims which the creditor does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him or her might have materially affected his or her settlement with the debtor."

I agree that I will indemnify and hold harmless the person's and agents against all claims, demands, and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.
