ARTICLE XIV – SCHOLARSHIPS

- 14.1 A scholarship fund shall be established and maintained.
- 14.2 A scholarship shall be presented to a Ferndale 4-H graduating senior who meets the following requirements:
  - Level I
    - a. Is currently enrolled in Ferndale 4-H
    - b. Has a minimum of 4 years in 4-H.
    - c. Plans to attend a vocation, Jr. College, or 4-year College.
    - d. Turns in the completed Scholarship Application Form to the Community Club Leader by April 1.
  - Level II
    - a. Meets Level I requirements.
    - b. Has held a club office or holds a Level 2 proficiency in one project.
    - c. Has chaired a major club event (such as pancake breakfast)
  - Level III
    - a. Meets Level I requirements.
    - b. Has completed two years of Jr. or Teen leadership.
    - c. Holds a gold star rank
    - d. Has held at least one club office or demonstrated a major leadership role (such as chairman of a major club event).
- 14.3 Scholarship award shall be Level I \$100.00, Level II \$250.00, Level III \$500.00 subject to change if funds are unavailable as determined by the Executive Board.
- 14.4 Scholarship shall be paid to recipient after award by applying in writing to Community Club Leader and sending verification of enrollment at a post-secondary school.
- 14.5 Scholarship recipients will receive a certificate of award at the Annual Achievement night banquet.

ARTICLE XV – AMENDMENTS
